For all dogs' health and well- being we ask that you please make sure your dog is free of fleas and ticks, and reasonably clean and groomed. If we find pests, or detect a stinky odor we will flea dip and/or bathe at the owner's expense.

Food should be brought for overnight stays, Dog Days of Sommer does not provide food. If Dog Days of Sommer has to provide food, there will be a \$2.00 per meal charge. Food should be brought in a container, preferably individually wrapped, with feeding instructions.

DDOS reserves the right to have your dog removed from the premises in cases of abandonment. **If your dog is not picked up THREE days from the projected pick up date which has been agreed upon, and you have made no contact with us for future arrangements animal control will be notified and your dog will be taken because of abandonment.** All we require is a phone call saying your plans have changed. If you are late picking up for daycare or boarding there will be a late fee, depending on how late you are. If you plan on boarding for a week or more, we ask that you pay at least 1/2 of the bill in advance. No refunds will be given for daycare days paid for in advance.

I understand and agree that in admitting my dog(s) to Dog Days of Sommer (DDOS) Doggy Daycare, Boarding, or Grooming the owners and their employees relied upon my honest

representation that my dog(s) has/have not harmed or shown any type of aggression or threatening behavior to any other dog or person, and is in good health.

I further understand and agree that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are attending DDOS. I agree to indemnify, defend, and hold harmless DDOS dog daycare and boarding, and it's employees, officers, directors, and volunteers, from any and all claims, damages, or causes of action arising from my dog(s) attendance at doggy daycare and/or boarding. I understand that it is my responsibility to pay for any and all damages arising from my dogs attendance at DDOS

I further understand and agree that DDOS and their staff and volunteers will not be held liable for any problems that may develop (i.e. injuries, fleas, ticks, illness ect.) provided reasonable precautions were taken and care were followed, and I hereby release them of any liability of any kind what so ever arising from my dog(s) attendance at DDOS

I further understand and agree to waive and release DDOS, and it's employees, officers, directors, and volunteers, and agents of any kind from any liability of any nature for any injury, death, or loss of my dog(s) resulting from DDOS actions or the actions of my dog(s) or any other dog while in the custody of or on the grounds or surrounding area of DDOS

In the event that my dog(s) causes injury to another dog or person while at DDOS, I agree to indemnify and subrogate DDOS from any action which may be brought against it and for any defense, settlement, or judgement entered against it. I will assume all liability for the actions of my dog(s) and agree to maintain personal liability to cover me in the event of such an incident.

I further understand and agree that any problem arising with my dog(s) will be treated as deemed necessary by the staff at DDOS. I assume full financial responsibility for any and all expenses involved, including but not limited to veterinary, property, and medical bills. If necessary I give my permission for the owner or employee of DDOS to take my dog to their residence.

I certify that I have read, understand, and agree to the rules and regulations set forth by this document. I further agree to abide by these rules and regulations and accept all the terms, statements, and conditions of this agreement.
